- The Republic of Vanuatu has received a loan from the Asian Development Bank (ADB) and a grant from the New Zealand Ministry of Foreign Affairs and Trade (NZMFAT) towards the cost of the Vanuatu Inter-Island Shipping Support Project. Part of the funding will be used for the provision of shipping services to remote areas. A contractor will be selected by competitive bidding to provide a monthly service between Port Vila and specified call points in Tafea Province.
- Bidding will be conducted under Vanuatu procurement rules with minor amendments to comply with ADB Guidelines for National Competitive Bidding (NCB) using a Single-Stage One Envelope approach. Bidding is open to bidders from eligible member countries of the ADB.
- The Ministry of Infrastructure and Public Utilities invites sealed bids from eligible bidders for the provision of a monthly passenger and cargo shipping service from Port Vila to Aneityum and specified call points on the west coasts of Erromango and Tanna. The contract period is one (1) year.
- 4. Bids are invited from companies offering vessels that meet the following requirements:
  - a Near Coastal or higher safety classification,
  - is certified for at least 60 passengers,
  - has a cargo capacity of at least 80 weight tonnes or 80 cubic metres, and
  - has a minimum speed of 7 knots.
